

# About myusic.ai

Myusic AI is an innovative platform that blends Artificial Intelligence, Web3, Intellectual Property (IP), and Real World Assets (RWA) to revolutionize music creation, ownership, and monetization. It enables anyone to generate unique AI-powered music, secure full IP rights on blockchain, tokenize these rights as RWAs, and trade or earn from them in a decentralized marketplace. Myusic AI transforms music from just an art form into a tangible, tradable asset.

### Problem Statement

#### Royalties are opaque and unfair

- Global: Recorded music revenue USD 26.2B (2022) → USD 29.6B (2024), but streaming payouts to artists remain <15% (IFPI).</li>
- Indonesia: Market size USD 190M (2022) with 87M paid users, yet royalty distribution often delayed 6–12 months.

#### Piracy destroys value

- Global: USD 12.5B annual losses due to illegal distribution (IFPI).
- **Indonesia**: Platforms like Stafaband & GudangLagu consistently among top visited music sites, undercutting creators (Kominfo takedown reports).

#### **111** Indie creators are excluded

- Global: Major labels capture ~70% of streaming revenue.
- Indonesia: Despite USD 127.4M digital revenue (2024) (Omdia), indie musicians still depend on offline gigs and lack access to financial products.

#### Fans remain passive

- **Global**: 752M streaming subscribers (2024), no ownership or participation (MBW).
- Indonesia: Heavy Spotify/Joox usage but no mechanism for fans to invest or co-own the music they love.

Global recorded music reached USD 29.6B in 2024 (+4.8% YoY) (IFPI).

Streaming alone hit USD 20.4B (69% share) with 752M paid subscribers (MBW).

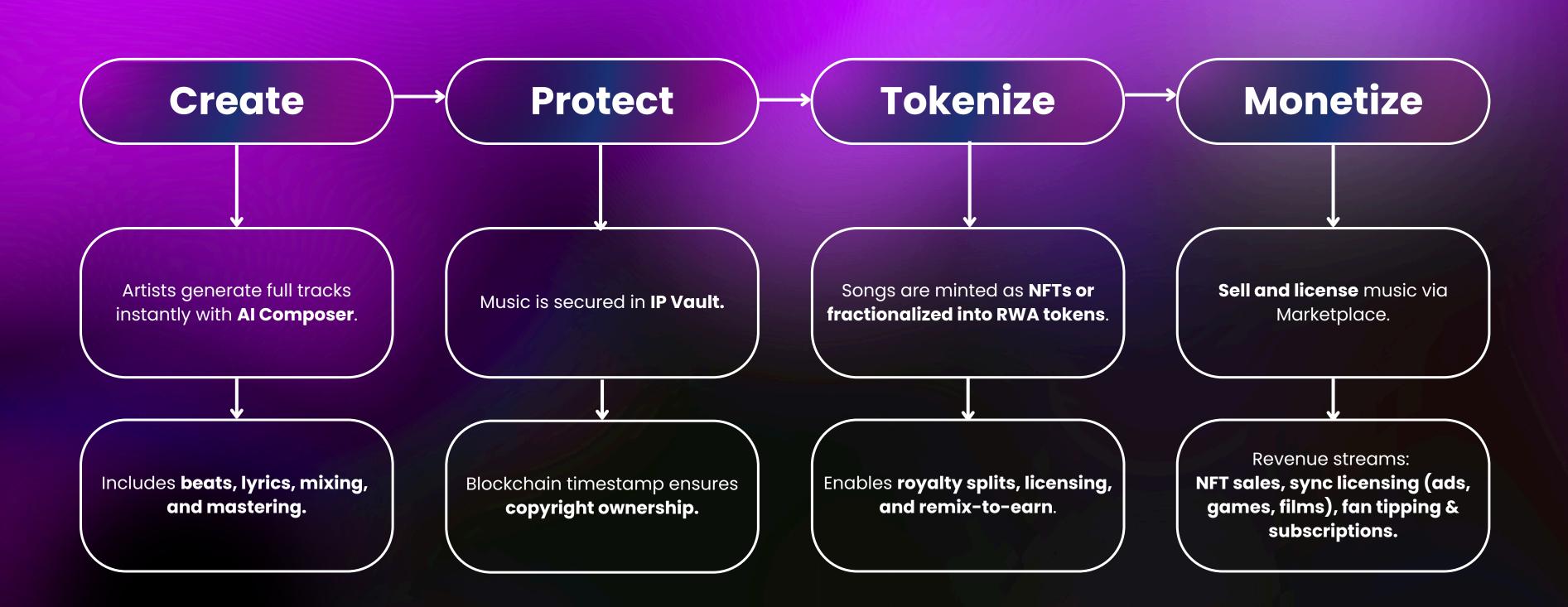

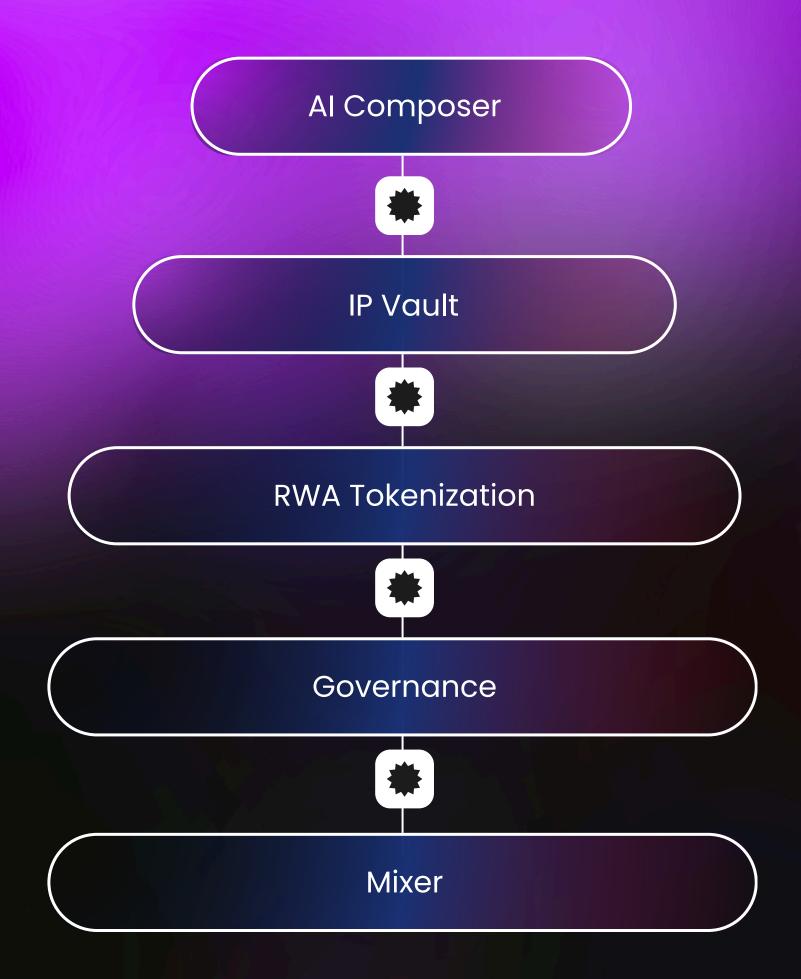

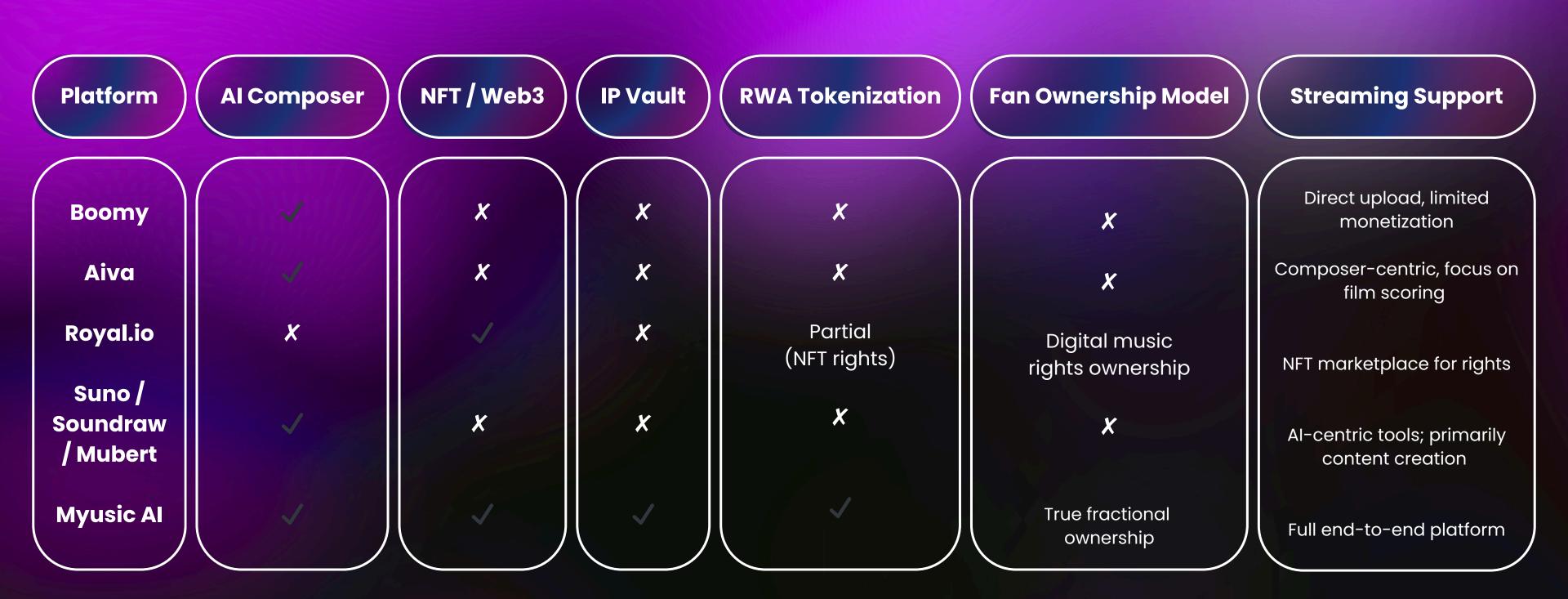
